- i) The Central Bureau of Investigation (CBI), Special Judge (PC Act) CBI, Coal Block Cases 01, New Delhi, vide its order dated 9th December, 2024, had convicted Shri Ramesh Jayaswal, Promoter and Managing Director of JNIL, along with other person(s)/Company which are not connected to JNIL, in respect of allocation of Coal Blocks (Brinda, Sisai and Meral) in the State of Jharkhand in favour of M/s Abhijeet Infrastructure Private Limited, in which Shri Ramesh Jayaswal was the then Authorised Signatory.
